- Handling and disposal of waste through safe and environmentally sustainable methods.

Energy and water

- Seek to reduce the amount of energy used as far as reasonably practicable.
- Lights and electrical equipment will be switched off when not in use, PIR sensors are installed throughout the building.
- Heating will be adjusted with energy consumption in mind.
- The energy consumption and efficiency of new products will be considered when purchasing.
- Renewable energy in the form of solar panels are installed.
- Rain water harvesting fed back into the waste water system.

Supplies

- AJW will evaluate if the need can be met in another way and evaluate if renting/sharing is an option before purchasing equipment.
- Evaluate the environmental impact of any new products we intend to purchase.
- Seek to buy more environmentally friendly and biodegradable products.
- Seek to reuse and recycle everything as far as reasonably practicable.

Transportation

AJW looks at ways to reduce CO2 emissions (carbon footprint) by means of:

- The company will seek to reduce the need to travel, restricting to necessity trips only.
- AJW will promote the use of travel alternatives such as e-mail or video/phone conferencing.
- AJW will make additional efforts to accommodate the needs of those using bicycles.
- AJW will look to encourage the use of 'green' vehicles that produces less harmful impacts to the environment.

Monitoring and improvement

- Comply with and, where possible, exceed all relevant regulatory requirements.
- Continually improve, evaluate, monitor and control the interactions with the environment as a result of our operations through the use of risk assessments, audits and procedural improvements aimed at reducing environmental impact and improving environmental performance.
